



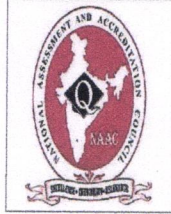

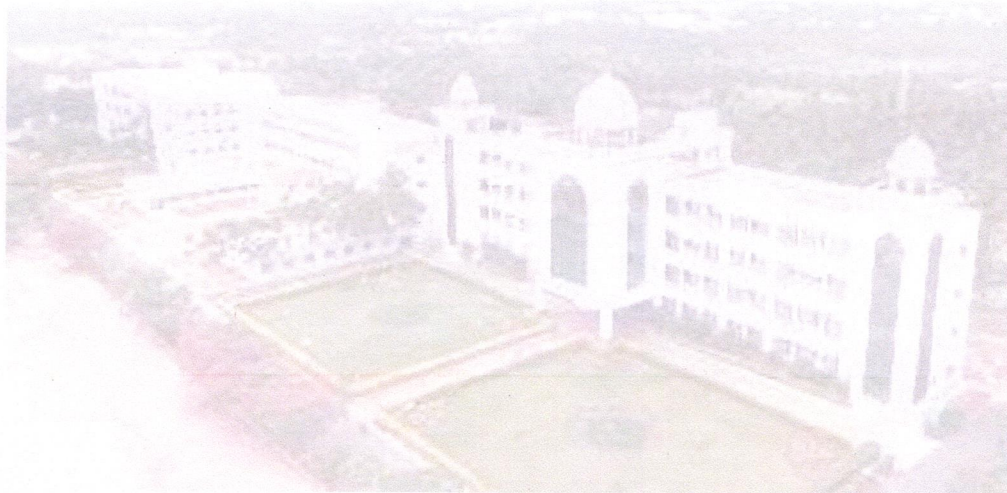

RESEARCH POLICY


The United Institute of Technology drafted the research policy in order to motivate and promote research in the campus which will directly and indirectly benefits the students and faculty members at large.

1. A senior faculty having academic and research experience will be appointed as head for coordinating various activities under the research committee.
2. The institution has a research committee chaired by the Principal to formulate and to promote research culture among faculty and students community.
3. Faculty members are encouraged to attend conferences and technology related training programs with financial assistance approved by the research committee.
4. Faculty members are encouraged to publish high quality research papers in journals listed by UGC Care.
5. Faculty members undergoing Ph.D will provided with leave concession to progress their research work.
6. Incentives/salary hike will be given to the members of faculty who completed Ph.D
7. Seed funding (Endowments funds) will be given as grant in aid for selective projects approved by the research committee.
8. The department can take up consultancy work from Industries and can share the revenue generated. The percentage of share towards faculty for rendering the consultancy work will be decided by the research committee and varies from time to time.
9. Follow the guidelines and regulations on research policy issued by the AICTE, NewDelhi and Centre for Research, Anna University, Chennai.
