POLICY DOCUMENT ON SCHOLARSHIP/FEE WAIVER

1.0 PRELIMINARY

1.0 APPLICABILITY AND COMMENCEMENT

The scholarship policy is applicable to all the programs, offered by United Institute of Technology (UIT) and it will come into force from the date of approval by the Governing Council of UIT.

2.0 INTRODUCTION

Scholarships play a defining role in the promotion of technical education among the meritorious and deserving students belonging to economically challenged and under privileged sections of the society. This fact is fully realized by the management, and it has consciously decided to implement various scholarship schemes to the students based on the available financial resources.

3.0. OBJECTIVE OF THIS POLICY

The objective of this policy is to lay down guidelines to be followed for disbursing scholarships and fee waivers to the students at UIT.

3.0 SCHOLARSHIP SCHEMES AT UIT

UIT offers the following scholarships for deserving students.

- Merit scholarship scheme
- SC / ST scholarship scheme
- · Referral scholarship scheme
- · Special scholarship scheme.

4.1. Merit Scholarships Scheme

The merit scholarship is meant for students who are academically meritorious and to encourage them to pursue their further education this scheme is created. It acts as a reward for them and motivates them to realize their dreams.

The fee waiver depends on the cut off marks secured in the higher secondary examinations and is given below.

- ✓ If the score is 180.75-200, 100% fee waiver on tuition fees
- ✓ If the score is 170-179.75, 75% fee waiver on tuition fees
- ✓ If the score is 160-169.75, 50% fee waiver on tuition fees
- ✓ If the score is 150-159.75, 25%e fee waiver on tuition fees.

4.2 SC / ST Scholarship Scheme

The SC/ST scholarship is offered to students from scheduled caste (SC) and scheduled tribe (ST) communities, and it helps them to pursue higher education. The scheme includes free transportation for day scholars and a 50% waiver for hostlers.

4.3 Referral Scholarship Scheme

The referral scholarship is awarded to students based on the recommendations from trustee members Headmasters/Principals of Government schools and colleges, and alumni. This scheme is designed to assist deserving students in completing their higher education.

4.4 Special Scholarship Scheme

4.4.1. Single parent Scholarships

This scholarship is to support students who survive with a single parent. Hence, considering the income of their family and the eligibility of the candidate, this scholarship will be given.

4.4.2 Scholarships for economically weaker sections

UIT provides scholarships to economically weak students as well as grants for low-income students to complete their higher education. The income margin will be decided by the governing council.

4.4.3. National/State/District Level Sports Scholarship Scheme

The National/State /District level scholarships will be decided based on the achievements in sports tournaments at National/State /District level.

4.4.4. The COVID-19 Relief Scholarship

A COVID-19 Relief Scholarship is an initiative that supports children who are left vulnerable and with very little or no financial support for their further education owing to a COVID-led crisis (family or financial) in their family.

5.0 HOW TO APPLY

- All the students of UIT submit their admission application form with the necessary certificates during the first or lateral entry admissions.
- The governing council selects the deserving applicants for the scholarship program based on their category.
- These scholarships are applicable to the students for the entire course of study.
